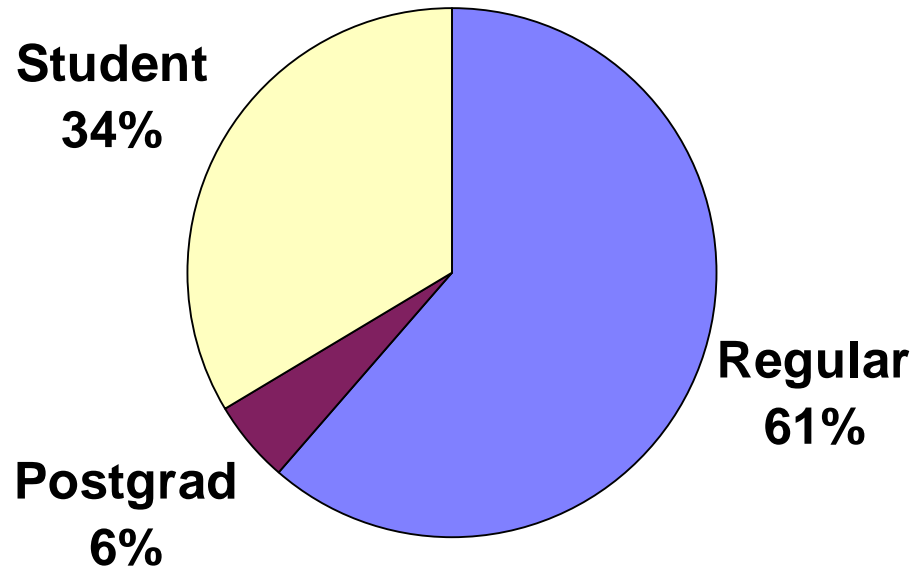

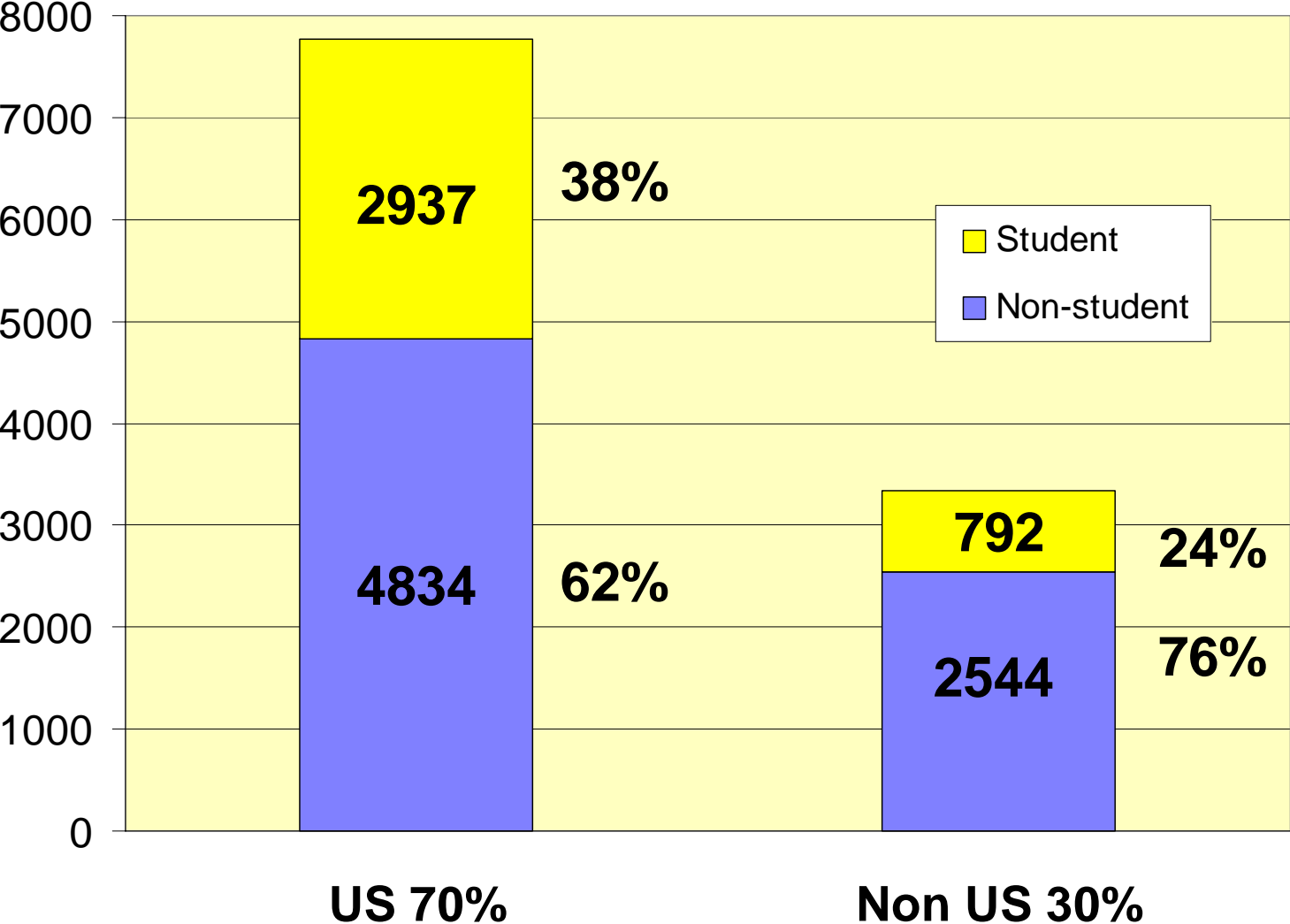

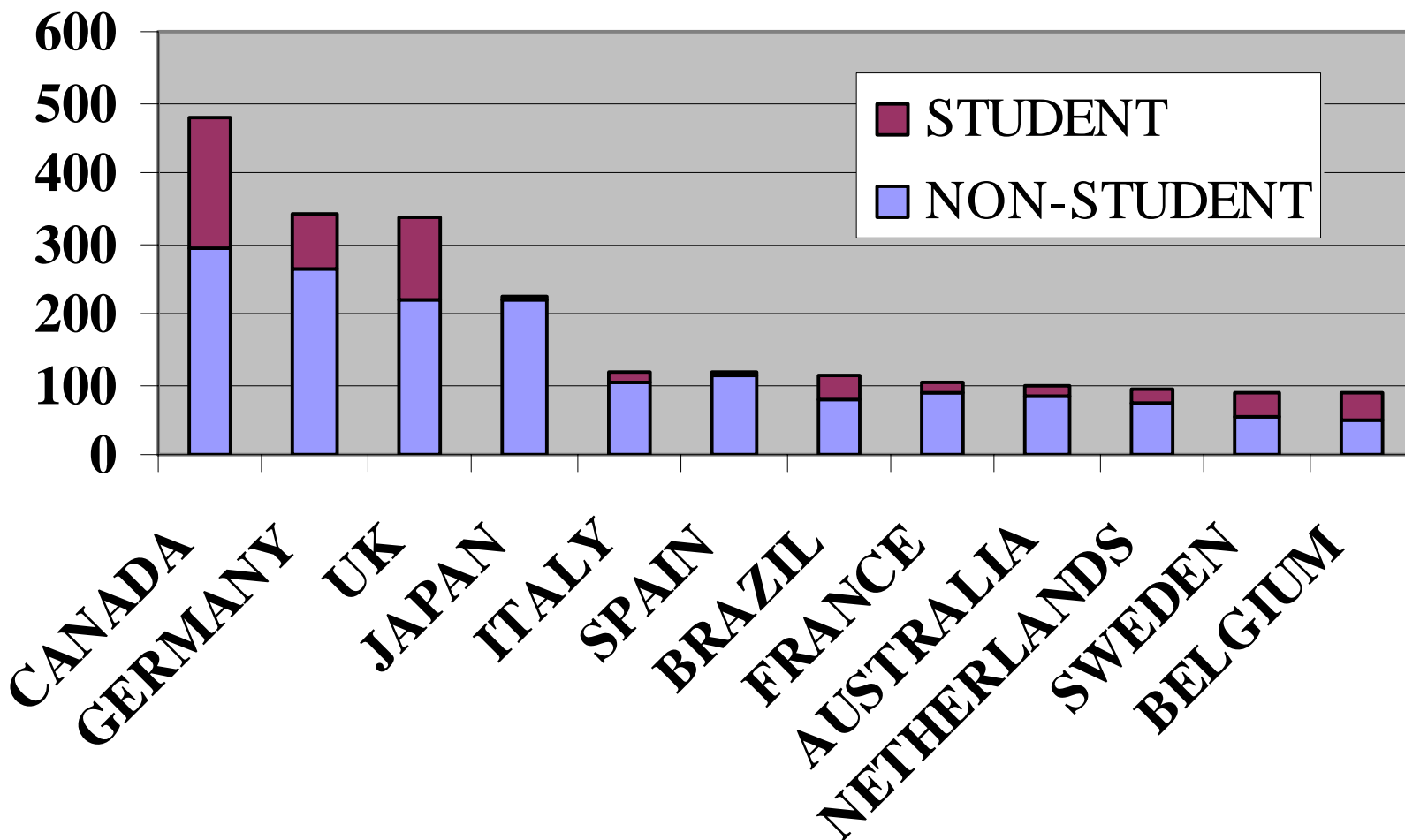

GEOGRAPHY MEMBERS 12/31/06

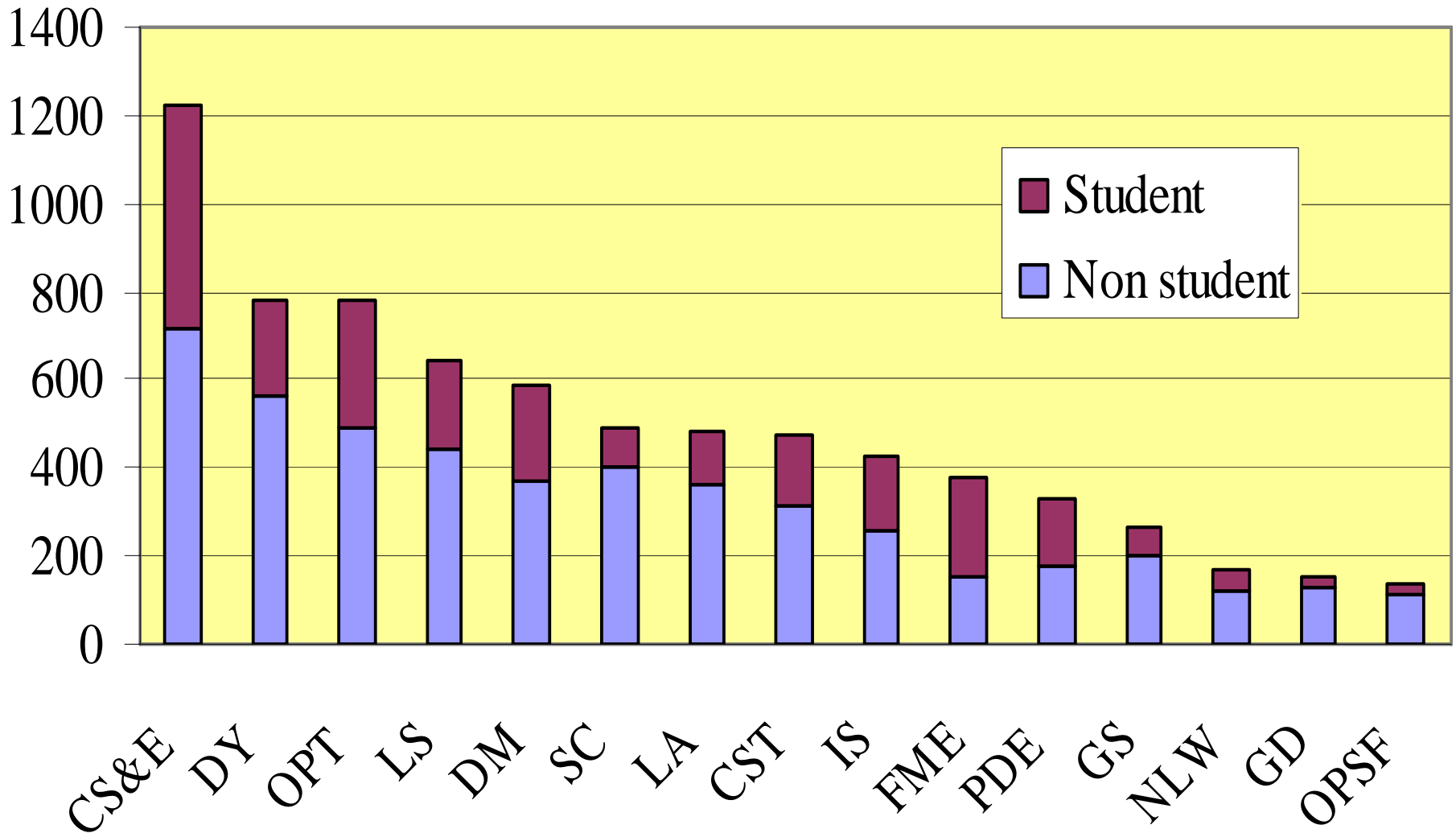


TOP COUNTRIES OF RESIDENCE OF MEMBERS OUTSIDE THE US

42% NON STUDENTS & 63% STUDENTS JOINED A SIAG

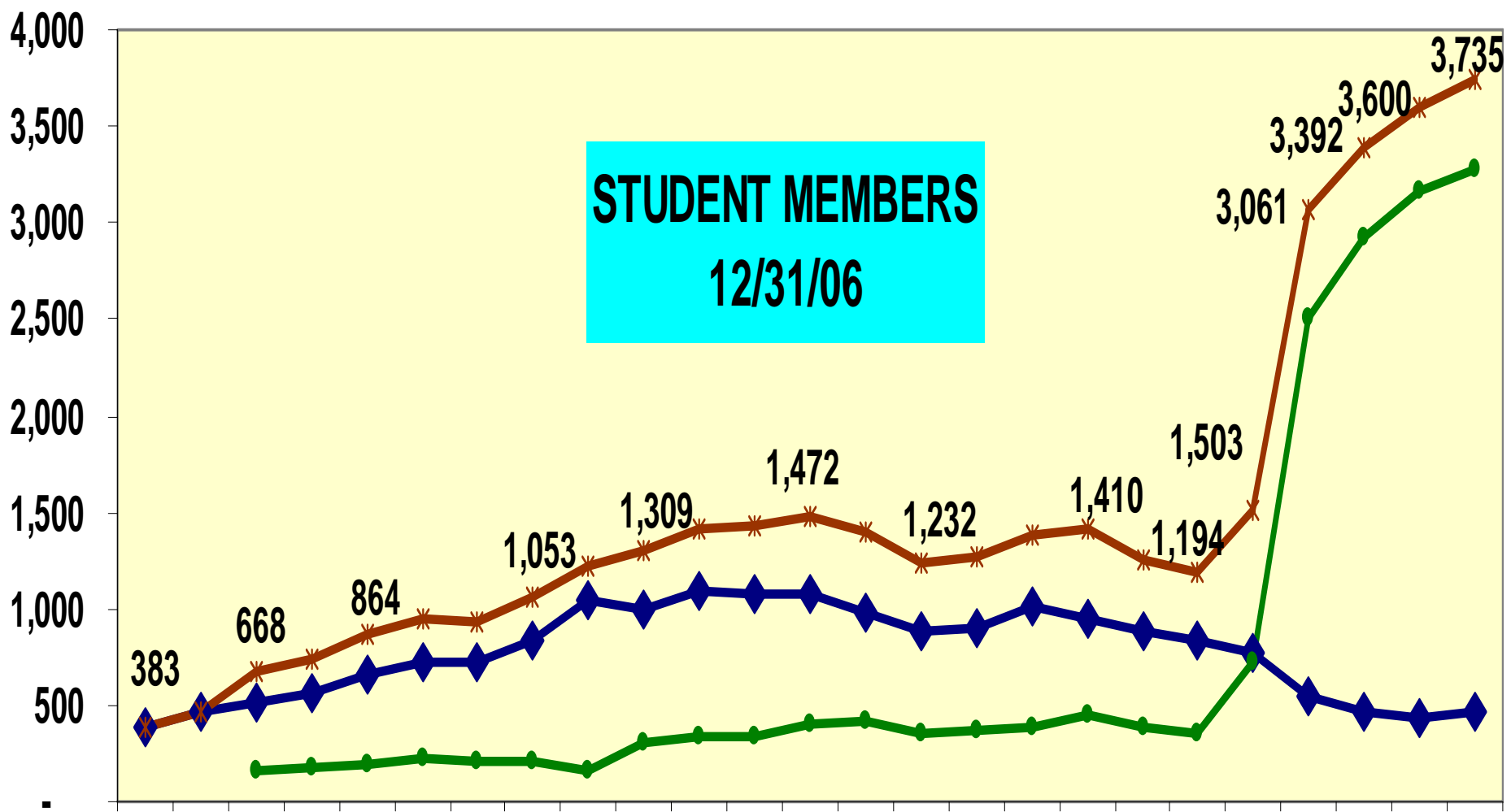

- 2011 Next ICIAM – SIAM/CAIMS/MITACS

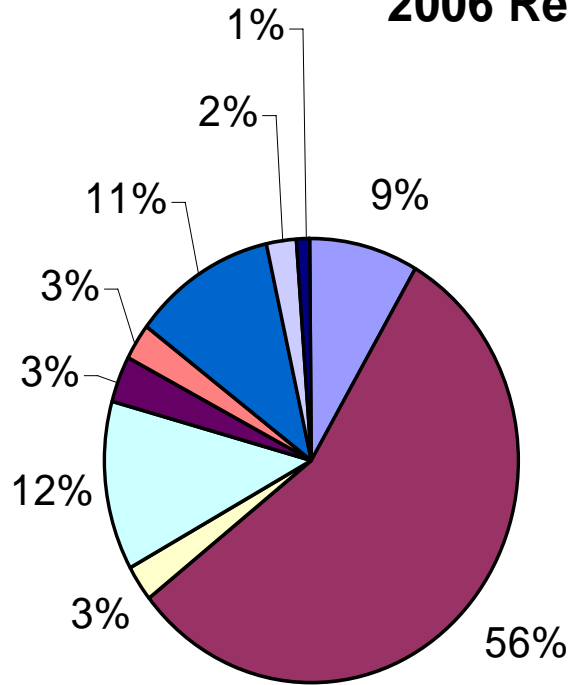
ICIAM 2011 Vancouver

SIAM's Financial Picture

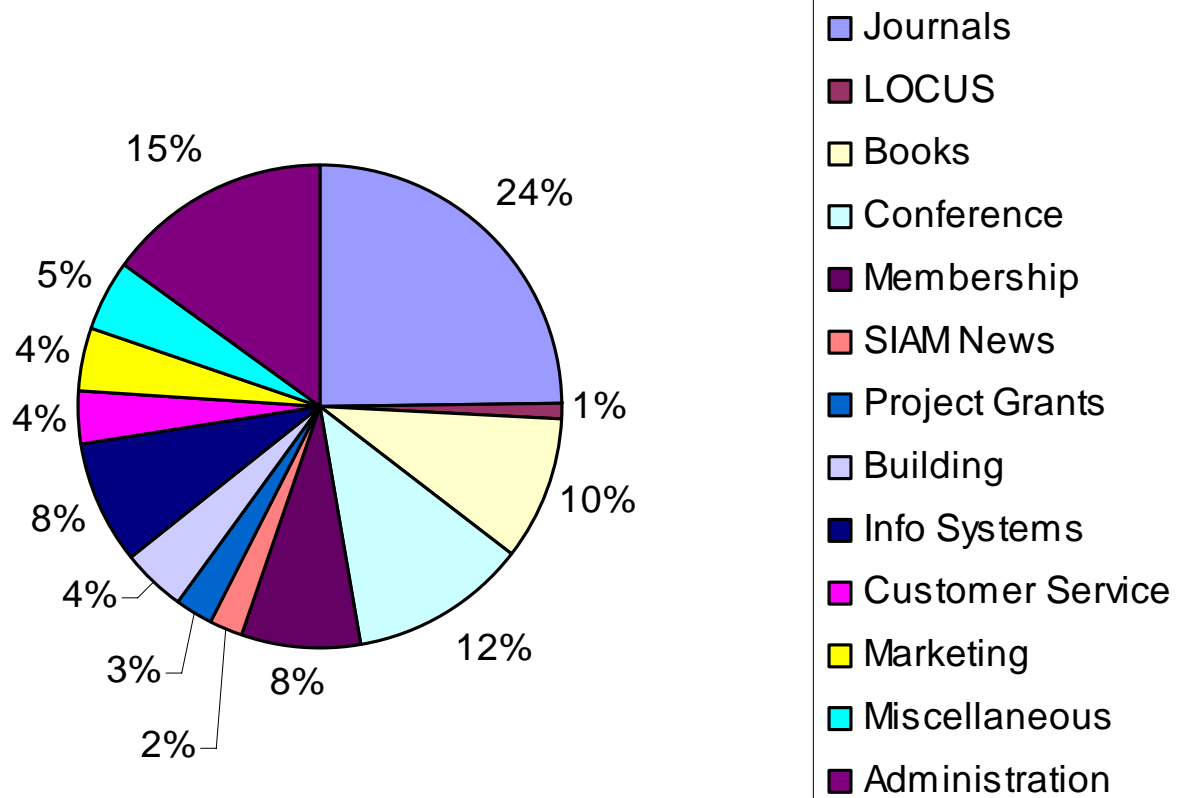
- SIAM's Finances Overseen by the Board of Trustees and its Financial Management Committee (FMC)
